

2016 SUMMER SCHOOL ON CONSUMER'S RIGHTS AND MARKET REGULATION IN THE EUROPEAN UNION UDINE, 18 JULY – 22 JULY

OVERVIEW

The Summer School "Consumer's Rights and Market Regulation in the European Union" is organized by the Università degli Studi di Udine in cooperation with an international consortium including De Montfort University (UK), University of Essex (UK), University of West Timisoara (Romania), European Law Faculty of Nova Gorica (Slovenia), and University of Belgrade (Serbia).

The lectures will be held in English language and will focus on some of the most relevant aspects related to consumer protection and market regulation in the European Union Law, such as:

- General consumer protection law the EU Directive on Consumer Rights;
- B2C contracts, unfair terms in B2C contracts and unfair commercial practices
- Specific contracts consumer sales, consumer credit;
- On-line auctions:
- Financial services and protection of private investors;
- Consumer protection in international relationships applicable law, jurisdiction, trans-border enforcement.

Objectives:

- To offer a quality and intensive training in consumer law, focusing on transnational developments at the EU level;
- To promote the sharing of knowledge, experiences and practices between participants from different countries and to encourage comparison between legislative solutions;
- To provide students with a solid and high-quality knowledge on course's topic and help them in developing incisive reasoning skills and other soft skills such as team working, problem solving and argumentative reasoning;
- To consolidate an international network of expertise in consumer law.

After completing the Summer School, students will have a good command of EU consumer protection rules and they will be able to identify whether or not EU consumer law governs a given situation and, if it does, which rules apply, in conjunction with national law.

Selected students will not pay any tuition fee.

HOW TO APPLY

The application period runs **from 1 April to 30 June 2016**. Students who are interested in applying must send an e-mail to <u>ip.europeanlaw.uniud@gmail.com</u>. Then the application form will be immediately sent them by the organization. Applicants shall fill in the application form and then send it back to the organization by e-mail at the same address.

No more than 25 participants will be admitted.

Students enrolled in a University program in Law or in Economics with an interest in the field of consumer protection, market regulation and European Union Law are the ideal candidates for the application. Anyway, Ph.D. students and post-doctoral researchers in any of the above areas are also encouraged to apply.

The working language of the summer school is English: a good command of English is therefore essential.

TEACHING PERIOD

The summer school will be held from 18 July to 22 July 2016.

It will consist of 30 hours of teaching activities, including traditional ex cathedra lectures, workgroups, moot court and a half-day final workshop.

ACCOMMODATION AND MEALS

Costs for accommodation in Udine will be wholly covered by the organization **only** for **non-Italian participants**.

Costs for meals at the University canteen will be wholly covered by the organization **both for Italian and non-Italian participants**.

CERTIFICATE AND ACCREDITATION

Participants who actively participate in the whole course and successfully complete the assigned coursework will be issued with a certificate of attendance.

The course has been credited by the Department of Law of the University of Udine with 2/3 ECTS (European Credit Transfer and Accumulation System) credits for students enrolled in the Law Master's Degree Course and in the Law for Enterprises and Institutions Bachelor Degree Course at the University of Udine.

HOW TO GET TO UDINE

Do you come by plane?

The Regional Airport (Ronchi dei Legionari) is 41 km far from the city.

Public Transport company APT operates bus services connecting the airport to **UDINE** (**Coach no. 51 - also non-stop via motorway**).

Updated schedules and fares are available on APT Gorizia website.

Tickets can be purchased at the airport:

- in the Arrivals Hall, with an automatic machine for self-ticketing;
- in the Departures Hall, at the Tourist Information desk (Turismo FVG).

If you land at Venice – Marco Polo Airport or Treviso Airport, then you can easily reach Udine by train, starting from Venice – Mestre or Treviso Centrale train station.

Once you've arrived in Udine, you can reach the Residenza Universitaria from the Udine train station (100 m away from the coach station) by bus (bus no. 7, bus no. 9 and bus no. 10)

Do you come by car?

A4/A23 motorway goes through Udine. If you come from North (Austria), take the "Udine nord" exit. If you come from all the other directions (Venice and Trieste/Slovenia), take the "Udine sud" exit.
